2) Programme in B.A./B.Com English:

Program and Course outcomes:

BA First and Second Semester students are acquainted with the basic grammar components such as concord, possessive pronouns and adjectives, synonyms and antonyms, articles and prepositions, writing skills (paragraphs) letter writing, resumes writing and the use of maxims.

Optional students are acquainted with the basic literary terms and literary forms such as simile, metaphor, climax, personification, sonnet, lyric ballad, tragedy, comedy short story, etc. Students are acquainted with the British writer and different period of English literature.

B.A. Third and Fourth Semester students are acquainted with modern English grammar elements such as sentence patterns, sentence structures, sentence processes, determiners, modifiers, clauses, phrases, etc. The representative poems and prose lessons helped students to know about the life values and nature's descriptions. The prose lessons acquainted the students with the mighty minds such as Tolstoy, Abraham Lincoln, Charles Darwin, St. Joan.

B.A. Fifth and Sixth Semester students were acquainted with the origin of the English language and different periods in the history of the English language. The discussion on the vocabulary helped students to know the contributions of the Greek, Latin, French languages to the development of the English language. The topics on the literary criticism helped students to know the latest developments in the field of literary criticism. The modern critics like Allen Tate, Empson, I. A.
